NATURE CONSERVATION

- 1 Always remain on boardwalks and in designated areas.
- 2 Please refrain from harming or collecting flora and fauna
- 3 Smoking and open flames are strictly prohibited in shitsugen(wetlands), boardwalks, and mountain trails.
- 4 Since there are no garbage facilities, please carry out garbage with you.(Please make efforts to reduce waste when you pack your supplies.)
- 5 To prevent the invasive species, please thoroughly clean mud and soil from your shoes before entering the area.

WALKING

- 1 Please keep to the right side of the boardwalk and give priority to uphill traffic when the path is narrow.
- 2 Be cautious of sunburn as the sunlight can be intense during the day.
- 3 The altitude will reach around 1,800 meters. As such, be prepared for chilly mornings and evenings and take steps to prevent altitude sickness.
- 4 Please bring rain wear and warm clothing. Weather conditions can easily change.
- 5 Please watch your step. Some sections of boardwalks may be damaged or slippery.
- 6 If you encounter a bear, never approach it. Especially avoid getting close to bear cubs as the mother bear may attack to protect her young.

- 1 Please follow the guide's instructions.
- 2 There are no medical facilities in Oze.

- 3 Please make payment to the staff on the first day of the tour. Payment can be made in Japanese yen or by credit card. Further payment details will be sent in an email after you submit your application.
- 4 Dispatch of the Final Itinerary: The final itinerary will be emailed to the client.
- 5 Travel Departure Day: Please gather at the meeting point and time designated in the final itinerary. Temperature checks will be conducted during check-in, so please be aware of this in advance.

Cancellation Policy: The cancellation dates and corresponding cancellation fees are as follows, counting back from the day before the start of the trip:

- Free cancellation up to 21 days prior to the trip
- 20 to 8 days prior: 20% cancellation fee

- 1 day prior: 40% cancellation fee
